

# LOCAL MAKER PROGRAM

Thank you so much for your interest in becoming a Local Maker partner!

Sneed's Nursery is proud to provide a space for local artists to offer their work for sale and connect with the community.

We feature local makers on a quarterly basis. The quarters are Spring, Summer, Fall, and Holiday, they span 3 months each and begin on January 1<sup>st</sup> (or the first day we return after the New Year). These names reflect the general theme that will be present in the shop but are not necessary to follow closely, we will schedule your feature time based on your work and make requests if there are items we feel will sell best. You may be paired with one or two other artists for the quarter.

You are welcome to bring items of any price point and size, within reason. We are a physically small shop and usually have one table dedicated to the makers. We have some space for backstock but not a ton so try to keep that in mind when choosing product. Please also keep in mind that we don't carry smoking apparatus or overtly adult products. Based on previous features the most commonly sold price point is \$15-\$20 but we have sold pieces in a very wide range of prices.

Local makers receive 60% of all sales and Sneed's receives the remaining 40%. This applies to all makers.

### About the information we need:

Included is an inventory sheet for you to fill out and hand in with your products by the 20<sup>th</sup>. We will confirm your inventory when we count the product we've received and update it at the end of the quarter with final stock and any damages. You will receive that total count with your check when you come in to pick up your products. We will reach out at the end of the quarter, but generally you will be able to pick everything up by the 10<sup>th</sup> of the following month.

Sneed's adds a 40% consignment charge to the items for sale and at the end of the quarter you will receive 60% of any sales or damaged items (treated as sales) via check. When you are filling out the inventory you only need to fill out the cost, which is your take home percentage. You're welcome to indicate the retail price instead but it will not change the percentages. If you're not sure about how to price your work or write a statement, we are always available to give advice or provide a sample template.

This packet contains a contract for the sale period and a contact info form, please fill them out and return to <a href="mailto:sydney@sneedsnursery.com">sydney@sneedsnursery.com</a> or the cashiers in the cottage by the 20<sup>th</sup> of the month <a href="mailto:before">before</a> your work is scheduled to be displayed.

Please keep in mind that the planned quarter in which your work is to be displayed is not necessarily set in stone. If any of these items are not completed by the deadlines given or if you need to choose another quarter for any reason, we cannot guarantee that you will be hosted for the upcoming quarter but we will try to fit you in or reschedule your display period.

We are so excited to work together to provide a space for artists to reach (and expand) their audience.

## SNEED'S CONSIGNMENT CONTRACT

#### Contract Details:

Consigner owns the product and grants the right to sell the product to Sneed's. Consigner will deliver product to Sneed's on the arranged date and will pick up remaining product on the contract termination date along with payment for product sold. Consigner is allowed to remove product from retail location at any time but must allow Sneed's 48 hours to prepare product to be removed. Upon removal of product, Consigner must enter into a new contract to resume sale.

### Agreement of the Parties:

The Consigner will provide an inventory or invoice to Sneed's at the time of delivery with pricing.

Sneed's shall be liable for damage occurring to the Product if it is damaged before sale.

### Payment Terms:

All sales of product will result in 60% of the price going to the Consigner and 40% going to Sneed's. Consigner will receive payment for product upon pick up of product from retail location. Sneed's shall keep accurate and updated records of sales that Consigner may inspect at any time upon request.
